Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **6.829** tCO_{2e} by 2029. This is a reduction of **40%**

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to **1.70** tCO_{2e}, a **15%** reduction against the 2023 baseline and the measures will be in effect when performing the contract

- Launched a hybrid approach to working for all staff, which supports homeworking and brings a reduction in the amount of carbon generated through employee commuting reducing the number of days in the office from 4 to 3.
- Agreed a hybrid approach to board and committee meetings, meaning less travel will be generated by our governance operations.
- Implemented a central control for the air conditioning.

In the future we hope to implement further measures such as:

- Launch an Environmental Policy which outlines our commitment to minimising the negative environmental impact of our activities.

- Facilitating the recycling and re-use of network hardware as the current staff laptops become outdated.


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
